

## MARINE AND COASTAL ACCESS ACT 2009

### PART 4: MARINE LICENSING

#### APPLICATION FOR A MARINE LICENCE TO UNDERTAKE GEOPHYSICAL, GEOTECHNICAL AND ENVIRONMENTAL MARINE SURVEYS OF THE PROPOSED GREENLINK CABLE ROUTE.

Notice is hereby given, in accordance with Part 4, Chapter 1, Section 68 of the Marine and Coastal Access Act 2009 that Greenlink Interconnector has applied to Natural Resources Wales, acting on behalf of the Licensing Authority, for a marine licence to undertake geophysical, geotechnical and environmental marine surveys of the proposed Greenlink cable route.
